NOTE A - NATURE OF ACTIVITIES AND SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES

Organization and Nature of Activities

Erin's Hope for Friends, Inc. (EHFF) was founded in 2014 and has the reputation of bridging the gap for autistic teens and young adults by providing a safe place to make friends. Erin's Hope for Friends is on a mission to create lasting relationships through joyful interactions for autism spectrum teens and young adults. They seek to fundamentally change the lives of kids on the spectrum by providing a safe, loving, and fun place for them to connect with others, build relationships and have fun. We desire to broaden the reach of EHFF by expanding the e club to new locations, eventually serving the entire population of children on the autism spectrum globally.

Financial Statement Presentation

Financial statement presentation is in accordance with accounting standards regarding the reporting of net assets. EHFF is required to report information regarding its financial position and activities according to two classes of net assets.

Net Assets without Donor Restrictions: Net assets that are not subject to donor-imposed restrictions and may be expended for any purpose in performing the primary objectives of EHFF. These net assets may be used at the discretion of EHFF's management and Board of Directors.

Net Assets with Donor Restrictions: Net assets subject to stipulations imposed by donors and grantors. Some donor-imposed restrictions may be temporary in nature, such as those that will be met by the passage of time or other events specified by the donor. Other donor-imposed restrictions may be perpetual in nature, where the donor stipulates those resources be maintained. EHFF received a donor restricted grant and met the restricted terms as stated in Note B. There were no restricted grants at December 31, 2022

Basis of Accounting

The financial statements of EHFF have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Net assets, revenues and expenses are classified based on the existence or absence of donor-imposed restrictions. Costs and expenses are recognized during the period in which they are incurred.

Recent Accounting Guidance and Change in Accounting Principle

EHFF has adopted the following Accounting Standards:

(ASU) No. 2018-08 Not-for-Profit Entities: Clarifying the Scope and the Accounting Guidance for Contributions Received and Contributions Made (Topic 605), was adopted on July 1, 2018 as management believes the standard improves the usefulness and understandability of EHFF's financial reporting.

(ASU) No. 2014-09 – Revenue from Contracts with Customers (Topic 606), was applied retrospectively with the cumulative effect of initial application at the date of July 1, 2018. EHFF does not believe the application of the provisions has a material effect on the amounts presented or disclosed as the Association has no material revenue subject to the standard.

EHFF will monitor and implement new accounting standards as required.

Cash and Cash Equivalents

EHFF considers all marketable securities and highly liquid investments with original maturities less than three months to be cash equivalents.

Accounts & Contributions Receivable

EHFF considers accounts receivable, which consist primarily of pledge donations in 2022, to be fully collectible; accordingly, no allowance for doubtful accounts is required. If amounts become uncollectible, they will be charged to operations when that determination is made. There are no accounts or contributions receivable at December 31, 2022.

Leasehold Improvements

Leasehold Improvements are recorded at acquisition cost less amortization accumulated over the useful life of the asset in accordance with the guidance of FASB ASC topic 360, *Property, Plant and Equipment*. Expenditures for maintenance and repairs are charged to expense as incurred, while renewals and betterments that materially extend the life of an asset are capitalized. The costs of assets sold, retired, or otherwise disposed of, and the related allowance of depreciation, are eliminated from the accounts, and any resulting gain or loss is recognized.

Amortization is provided using the straight-line method over the estimated useful lives of the improvement or the remaining terms of the lease, whichever is shorter.

Amortization expense for the year December 31, 2022 was \$0, due to the items not being put into service until April 2023.

Use of Estimates

Management uses estimates and assumptions in preparing financial statements in accordance with accounting principles generally accepted in the United States of America. These estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported revenues and expenses. Actual results could vary from the estimates that were assumed in preparing the financial statements.

Income Taxes

EHFF qualified as a tax-exempt organization as described in the Internal Revenue Code Section 501(c)(3). The EHFF follows the provisions of uncertain tax positions as addressed in FASB Accounting Standards Codification 740-10-65-1, *Income Taxes*.

FASB ASC topic 740, *Income Taxes*, provides guidance for how uncertain tax positions should be recognized, measured, presented, and disclosed in financial statements. FASB ASC topic 740 requires the evaluation of tax positions taken or expected to be taken in the course of preparing the EHFF's tax returns to determine whether the tax positions would "more-likely-than-not" be sustained if challenged by an

applicable tax authority. Tax positions not deemed to meet the more-likely-than-not threshold would be recorded as a tax benefit or expense in the current year. EHFF evaluates its uncertain tax positions using the provisions of FASB ASC topic 450, *Contingencies*.

Management believes there are no material estimates or amounts relating to uncertain tax positions that should be accrued as of December 31, 2022, respectively. EHFF believes it is no longer subject to income tax examinations for tax years prior to 2019.

Revenue Recognition

EHFF recognizes revenue when it is realized or realizable and earned. EHFF considers revenue realized or realizable and earned when it has persuasive evidence of an arrangement, delivery has occurred, the price is fixed and determinable, and collectability is reasonably assured. EHFF recognizes revenue from the following activities when earned:

Grant Revenue- EHFF receives grant revenue primarily from Fulton County. Grant revenue is recognized when collected. Grants are awarded and collected in the same period.

Sponsorship Revenue- EHFF receives revenue from its vendors for name placement at its events and also from the cities in which events are held for holding the event in their location. Revenue is recognized when the event occurs.

Deferred Revenue

EHFF records as deferred revenue any amounts that have been collected for services or events where revenue has not met the aforementioned revenue recognition principles. The EHFF had no deferred revenue for the year ended December 31, 2022.

Functional Allocation of Expenses

EHFF allocates its expenses on a functional basis among its programs and support services. The costs of providing the various programs and activities have been summarized on a functional basis in the statement of activities. Expenses that can be identified with a specific program or support service are allocated directly. Expenses common to several functions are allocated according to estimates developed by management. The expenses that are allocated include salaries, benefits, meetings, and travel, which are allocated on the basis of time and effort.

Program services are the activities that result in services to member schools that fulfill the purposes or mission for which EHFF exists. General and administrative activities are activities that are not identifiable with a single program but that are indispensable to the conduct of those activities and to EHFF's existence.

Leases

EHFF determines if an arrangement is or contains a lease at inception. Leases are included in right-of-use (ROU) assets and lease liabilities in the statement of financial position. ROU assets and lease liabilities reflect the present value of the future minimum lease payments over the lease term, and ROU assets also include prepaid or accrued rent. Operating lease expense is recognized on a straight-

line basis over the lease term. EHFF does not report ROU assets and leases liabilities for its short-term leases (leases with a term of 12 months or less). Instead, the lease payments of those leases are reported as lease expense on a straight-line basis over the lease term.

NOTE D – IN-KIND CONTRIBUTIONS

EHFF received various services, furniture, and fixtures for their leasehold improvements. NOTE E – OPERATING LEASE

Beginning in January 2022, EHFF recognizes and measures its leases in accordance with FASB ASC 842, Leases. On April 1, 2022, EHFF entered into a 38-month noncancelable operating lease for operations and ancillary administrative office uses related thereto. EHFF determines if an arrangement is a lease, or contains a lease, at inception of a contract and when the terms of an existing contract are changed. EHFF recognizes a lease liability and a right of use (ROU) asset at the commencement date of the lease. The lease liability is initially and subsequently recognized based on the present value of its future lease payments. Variable payments are included in the future lease payments when those variable payments depend on an index or a rate.

The discount rate is the implicit rate if it is readily determinable or otherwise EHFF uses its incremental borrowing rate. The implicit rates of our leases are not readily determinable and accordingly, we use our incremental borrowing rate based on the information available at the commencement date for all leases. EHFF's incremental borrowing rate for a lease is the rate of interest it would have to pay on a collateralized basis to borrow an amount equal to the lease payments under similar terms and in a similar economic environment. The ROU asset is subsequently measured throughout the lease term at the amount of the remeasured lease liability (i.e., present value of the remaining lease payments), plus unamortized initial direct costs, plus (minus) any prepaid (accrued) lease payments, less the unamortized balance of lease incentives received, and any impairment recognized. Operating lease expense is recognized on a straight-line basis over the lease term.

The average discount rate is 5% and the weighted average remaining lease term for operating lease is 30 months. EHFF entered into a lease agreement to rent office space located in Alpharetta. The lease terms were for 3,050 square feet with a 38 month, rent agreement. The monthly rent expense for the

NOTE F — CONCENTRATION OF CREDIT RISK

EHFF maintains its cash and cash equivalents with various financial institutions covered under the Federal Deposit Insurance Corporation (FDIC). These accounts are insured by the FDIC up to \$250,000. At times, the balance in these accounts may exceed the FDIC insured limit. EHFF has not experienced, nor does it anticipate, any losses with respect to such accounts.

NOTE G — SUBSEQUENT EVENTS

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through January 25, 2024 which is the date the financial statements were available to be issued. Events occurring after that date have not been evaluated to determine whether a change in the financial statements would be required.
